Purpose of role: To support the deepening and broadening of the Community Savers network: working with leaders to develop plans for their groups and communities; capturing and communicating learning and impact; and creating opportunities for savings mobilisation in new areas.

Duties and Responsibilities

Supporting community action

- Support Community Savers leaders in particular neighbourhoods to develop and progress their ideas for achieving positive outcomes for their members.
- Support Community Savers leaders to network together with other groups in their local area to develop new plans for their neighbourhood or for improving local service provision.

Development of the Community Savers network

- To work closely with the CLASS Director to support reflection and learning exchange among leaders across the Community Savers network
- To support effective documentation and communications of learning and achievements across the network and to diverse external audiences.

- Network and build relationships with community groups, community networks and statutory and non-statutory agencies in additional boroughs of Greater Manchester and in Sheffield to open up opportunities for learning exchanges with Community Savers groups and expansion of the Community Savers network.
- Support community groups in new areas to learn about the Community Savers approach and set up new groups, working closely with Community Savers leaders and the CLASS Director.

Monitoring and Evaluation

- Help to develop a new monitoring and evaluation framework for the CLASS-Community Savers alliance encompassing the breadth and depth of development outcomes, community action and impacts.
- Work with Community Savers leaders and the CLASS Director to carry out quarterly and annual monitoring and evaluation in accordance with the new framework including an annual impact study.

General duties

- Assisting with coordination and documentation of meetings and events
- Proactive management of workload and working hours (supported by monthly supervision meetings)
- Adherence to the CLASS code of conduct and all aspects of the CLASS Policy Framework.
- Other duties as required by the CLASS Director.
