# **Specification**

Our 2024 impact evaluation will be co-designed and co-delivered with the CLASS staff team, the Community Savers leadership, and the Evaluation team that we contract to work with us.

We have carried out our own annual impact evaluation since 2022 and we hope to use some of our existing approaches and tools while being open to new ideas for achieving a rich and constructive picture of what is happening across the network and our most recent outcomes and impacts.

We measure our impact against our co-created <u>Theory of Change</u>. Methods and tools have previously included:

- Impact questionnaires and equality monitoring surveys with members of affiliated savings groups at weekly savings collections [administered by leaders of the groups together with CLASS Staff]
- Semi-structured interviews with a sample of Community Savers leaders (committee members of affiliated community associations) [CLASS Director]
- A partner survey [Google form]
- Financial analysis of savings groups records across all affiliated savings groups. [CLASS Operations Manager]
- Documentary review of newsletters, reports to funders, blog posts, strategy day and retreat reports, and other minutes and publications from throughout the year as necessary. [CLASS Director]

This year we would like to add:

- An equality monitoring survey of the CLASS staff team and board
- An equality monitoring survey of all committee members of affiliated groups
- A semi-structured interview with the CLASS Director (with the dual purpose of deepening the evaluation team's understanding of our work)
- Paired interviews with CLASS staff members

 A small number of semi-structured interviews with representatives of partner organisations including those engaged in Social Homes for Manchester and the Manchester Social Housing Commission.

Leaders and members of staff can work with the evaluation team to administer aspects of the data gathering process where appropriate/ necessary e.g. savers may be more willing to speak to people they know.

- 2. Co-creation workshop (2hrs) with CLASS staff & Community Savers leadership agreeing division of labour and co-design of tools [1 day]
- 3. Data gathering [4 days]
- 4. Data analysis and write up [4 days]
- 5. Verification of findings with CLASS team and Community Savers leadership [1/2 day]
- 6. Final report and dissemination [1 day]

- Details of key staff involved in delivery and ability to mobilise in line with our milestones
- Breakdown of costs for the work

In addition to the deliverables, we will also be evaluating against the following criteria:

- Understanding of the aims of CLASS / Community Savers and the aims of the evaluation
- Innovation and creativity
- A commitment to equal opportunities, ethical practice and your own social responsibility agenda
- Value for money
- Located in or near to Community Savers activity, as part of our commitment to supporting local economies
